The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

- 1. Review and approve the minutes of the December 12, 2017, and December 18, 2017 Board of Directors meetings;
- 2. Presentation by Enhanced Energy Services of America, LLC regarding electricity pricing;
- 3. Harris County Precinct Four Constable's Office security report; approval and execution of Interlocal Agreement for Law Enforcement Services between Harris County and the District for security patrol services from March 1, 2018, to February 28, 2019; consider amendment of Rate Order to address increased security costs;
