
The meeting will be held on *Tuesday, November 13, 2018, at 7:00 p.m.* 

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

- 1. Review and approve the minutes of the October 9, 2018, Board of Directors meeting;
- 2. Harris County Precinct Four Constable's Office security report;
- 3. Comments from the public;
- 4. Report by Republic Services, Inc. concerning solid waste collection activities within the District;
- 5. Tax Assessor-Collector report, including:
  - (a) Status of collection of delinquent taxes, including authorizing lawsuit and/or foreclosure, as appropriate; and
  - (b) Approval of installment agreements with taxpayers for the payment of delinquent taxes and status of existing installment agreements;
- 6. Report and legal action taken by the District's Delinquent Tax Collections Attorney;
- 7. Developers' reports, including the approval and execution of Utility Development Agreement(s) and/or Consent to Encroachment and Indemnity Agreements ("Encroachment Agreements") with Developer(s) relative to property within the District and the financing and purchase of infrastructure within the District;
