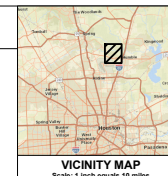

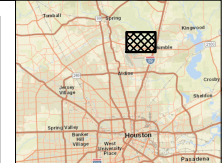

# Water Plant No. 3

This aerial photograph shows the layout of Water Plant No. 3. The facility is situated next to Lee Road, which runs vertically along the left side of the image. Two large, circular storage tanks are prominent: the 'Elevated Storage Tank No. 1' on the left and the 'Ground Storage Tank No. 1' on the right. Between them is the 'Control Building'. 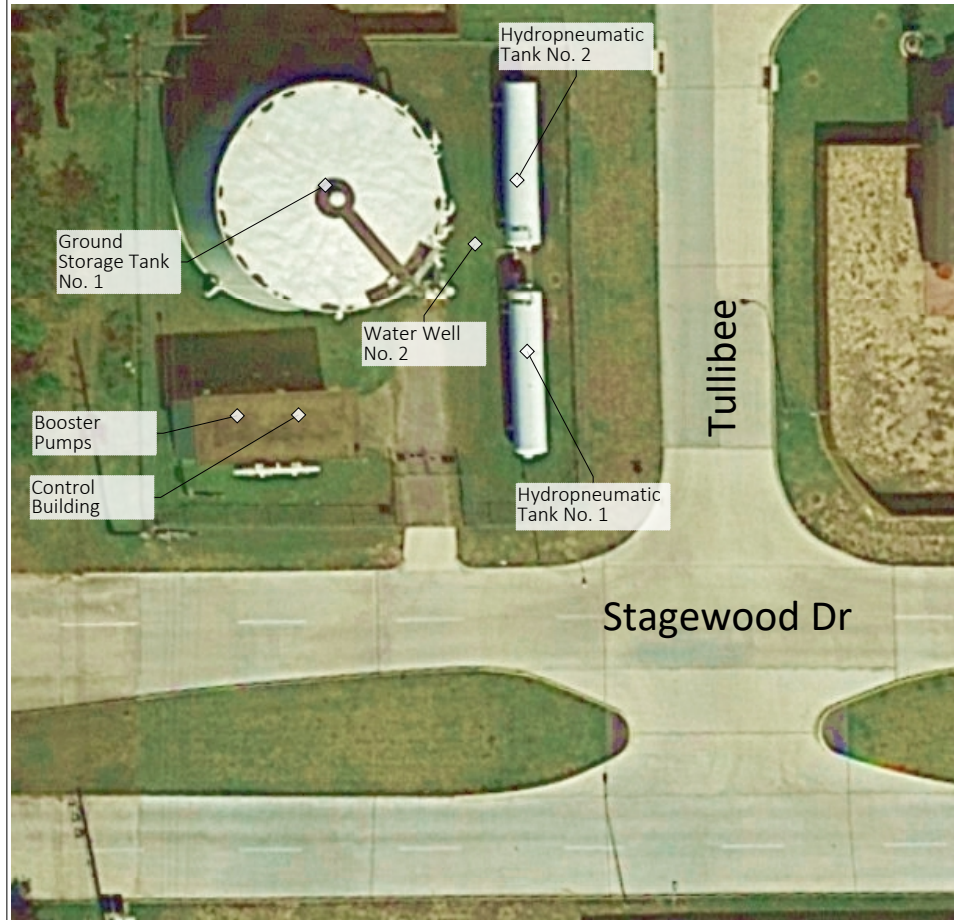

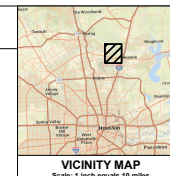
